D. Commentary

The 5pm daily ministerial media briefing was led by the Secretary of State for Health and Social care, Matt Hancock, who announced that for the first time since 18th March, there were no



deaths from COVID-19 recorded in Northern Ireland, and deaths across the UK have fallen to the lowest number for six weeks. That said, he pointed out that 8,802 people with COVID-19 still remain in UK hospitals.

Mt Hancock gave an update on two key elements of tackling the disease – personal protective equipment (PPE) and treatments.

- **PPE:** Production across the UK has increased, and the government has signed contracts to manufacture two billion items in the UK. Another 100 contracts have been signed with new suppliers of PPE in other parts of the world, including the provision of 3.7 billion gloves. The arrangements will boost the UK’s capacity to supply vital PPE to those that need it and will enable UK stockpiles to be replenished.
- **Treatments:** A new trial of an anti-viral drug known as [remdesivir](#) has been approved for use in the UK. It is the first medicine to be used to treat patients in UK hospitals suffering from COVID-19. The drug, produced by [Gilead Sciences](#), is intended to reduce patient recovery time by around four days.
