## D. Commentary

The 5pm ministerial briefing was given by the Foreign Secretary, Dominic Raab, who reported on statistical progress compared with one week ago, namely:

- 109 fewer daily cases reported
- 161 fewer patients in critical care in hospitals
- 155 fewer deaths

Mr Raab explained that progress was being maintained in bringing the spread of COVID-19 down and slowly re-opening the economy, noting that high street shops and outdoor visitor attractions had re-opened earlier in the day. He pointed out that work continues to enable the government to move to the third stage of its [recovery road map](#), which is planned to happen **no earlier than** Saturday, 4<sup>th</sup> July 2020.

Staff and volunteers at the forefront of the national coronavirus response across England are now able to access a new, free [psychological first aid training course](#). The new course has been developed by PHE with support from NHS England and Health Education England and is being made available to frontline workers across England by social learning platform, Future Learn.
