D. Commentary

The 5pm ministerial briefing was led by the Education Secretary, Gavin Williamson, who announced that the government is planning for all pupils in all year groups in all schools in England to go back to school full-time in September 2020. Guidance on safety measures will be published within the next two weeks.

Mr Williamson also said class size limits of a maximum of 15 pupils imposed to reduce the spread of COVID-19 could be increased to allow every child to return to school. This will depend upon the outcome of the government's current review of the effectiveness of the two-metre social distancing rule.

Earlier in the day, the Prime Minister announced a £1bn fund to help England's children catch up on what they have missed while schools have been closed. Further details are to be announced, but it is understood to include the provision of tutors through a £350m programme to help the most disadvantaged children. Primary and secondary schools will be given £650m to spend on one-to-one or group tuition for any pupils they think need it.

The government published, for the first time, the regional growth rates for COVID-19 across the UK, alongside the R number assessment.

There will not be any UK government ministerial media briefings over the weekend (Saturday 20th and Sunday 21st June 2020).

The government has reduced the COVID Alert Level from four to three as displayed in the chart below, meaning COVID-19 is in general circulation in the UK. This in turn allows a gradual relaxing of restrictions.

COVID-19 UK Alert Levels

Level	Description
5	As level 4 and there is a material risk of healthcare services being overwhelmed
4	A COVID-19 epidemic is in general circulation; transmission is high or rising exponentially
3	A COVID-19 epidemic is in general circulation
2	COVID-19 is present in the UK, but the number of cases and transmission is low
1	COVID-19 is not known to be present in the UK
