All items listed in the annex to this document are updated when government guidance changes. The links take you through to the latest information.

During the past week the government issued a range of [draft legislative options](#) for regional or local interventions if there are significant local or wide-area COVID-19 outbreaks. The options describe how ministers could use existing powers to control an outbreak if local action is insufficient, building on the approaches taken nationally and in Leicester.

Spain

A significant increase in the number of COVID-19 cases in mainland Spain has led to the country's removal from the UK travel corridor list. This means that from today, 27th July 2020, travellers arriving into England, Wales, Scotland and Northern Ireland from Spain will need to self-isolate for 14 days. Those already in Spain can stay for the remainder of their trip/holiday but will have to self-isolate upon return to the UK. The government now advises against all but essential travel to mainland Spain

Face coverings

Face coverings are now mandatory in all shops and supermarkets in England with effect from Friday 24th July 2020.
