International travel advice continues to be updated frequently as infection rates rise in some countries. The current guidance on countries and territories exempt from UK travel restrictions and subsequent self-isolation upon returning to the UK is available [here](#).

Public Health England has introduced a customer logging toolkit for businesses and organisations who are required to collect information about customers, staff, and visitors as part of the NHS Test and Trace service in England. Downloadable resources to help them do this are available [here](#).

From 1st September, the government furlough scheme payments reduced from 80% to 70% of wages up to a maximum cap of £2,187.50 for the hours the employee is on furlough. More information about the changes is available [here](#).

On 2nd September, the UK government launched a new [Kickstart Scheme](#) in England, Scotland and Wales, with a £2 billion fund to create hundreds of thousands of high quality six-month work placements aimed at those aged 16 to 24 who are on Universal Credit and are deemed to be at risk of long term unemployment. Funding available for each job will cover 100% of the relevant National Minimum Wage for 25 hours a week, plus the associated employer National Insurance contributions and employer minimum automatic enrolment contributions.
