D. Commentary

Lockdown Restrictions

England

[Regulations](#) setting out the new (third) national lockdown were approved by Parliament on 6th January 2021 and last until they expire on 31st March 2021. The associated [restrictions](#), including the resumption of [shielding](#), are subject of continuous government review.

Rapidly rising infection rates and associated health service pressures have prompted the UK government to launch a major new public campaign urging people to act like they have the virus. This campaign includes a TV advert fronted by the Chief Medical Officer for England, Professor Chris Whitty. The video is accessible [here](#).

Wales

Wales remains in lockdown under its [alert level 4](#).

Scotland

Scotland (other than some islands) remains in lockdown until the end of January 2021, when the situation will be reviewed.

Northern Ireland

A [six-week lockdown](#) began in Northern Ireland on 26th December, with a review on 21st January 2021.

Vaccination Programme

On Thursday, 7th January 2021, the [Prime Minister announced](#) the government's intention to vaccinate some 15 million people across the UK by mid-February 2021. The Health Secretary, Matt Hancock, is expected to provide information about the scaled-up vaccination programme later today, Monday 11th January 2021.

Third COVID-19 vaccine approved for UK use

On Friday, 8th January 2021, it was announced that the [UK regulator](#) had approved Moderna as the third COVID-19 vaccine for UK use.

The R number

The [latest R number](#) range for the UK is 1.1 - 1.4 (as at 8th January 2021) and the growth rate range is between 0% and +6%, meaning that the number of new infections is estimated to be either broadly flat or growing by up to 6% every day.

During January, the UK government will publish the R number estimate on these dates:

- Friday 15th January
- Friday 22nd January
- Friday 29th January



International travel

Different international travel rules apply in [England](#), [Scotland](#), [Wales](#) and [Northern Ireland](#) and it is essential to check [government foreign travel advice](#). In brief, under current restrictions people must stay at home and not travel, including abroad, unless they have a legally permitted reason to do so.

31st January 2021: closing date for applications for the [Future Fund](#).

31st March 2021: Closing date for applications for the [Coronavirus Business Interruption Loan Scheme](#), the [Bounce Back Loan Scheme](#) and the [Coronavirus Large Business Interruption Loan Scheme](#).

30th April 2021: [Coronavirus Job Retention Scheme](#) ends.

ENGLAND LOCKDOWN
STAY AT HOME

THE NEW VARIANT OF CORONAVIRUS IS SPREADING FAST. WE ALL NEED TO PLAY OUR PART TO STOP THE SPREAD.

- LEAVING HOME**
You must not leave, or be outside of your home or garden, except for a very limited set of exceptions e.g. to shop for basic necessities, exercise, go to work if you cannot do so from home, or to mitigate risk of harm.
- MEETING OTHERS**
You cannot leave your home to meet socially with anyone, except with your household or support bubble if eligible to form one. Stay 2 metres apart from anyone not in your household or support bubble.
- EXERCISE**
You may exercise on your own, with your household or support bubble, or with one person from another household (other than your own). Stay 2 metres apart from anyone not in your household or support bubble.
- BANK, PUBS AND RESTAURANTS**
Hospitality closed aside from sales by takeaway (until 11pm), click-and-collect, drive-through or delivery. Alcohol cannot be purchased through takeaway or click-and-collect from hospitality venues.
- RETAIL**
Essential shops can open. Non-essential retail must close and can only run click-and-collect and delivery.
- WORK AND BUSINESS**
Everyone must work from home unless they are unable to do so.
- EDUCATION**
Early years settings open. Primary and secondary school and colleges move to remote provision except for vulnerable children and children of critical workers. Most university students to move to remote learning.
- LEISURE AND SPORTING FACILITIES**
Closed, with limited exceptions.
- ACCOMMODATION**
Closed, with limited exceptions.
- PERSONAL CARE**
Closed.
- ENTERTAINMENT**
Closed.
- OVERNIGHT STAYS**
You must not stay overnight away from home. Limited exceptions apply e.g. to stay with your support bubble.
- WEDDINGS AND FUNERALS**
Funerals of up to 10 people permitted. Weddings of up to 10 people permitted in exceptional circumstances. Visas and other limited ceremonial events of up to 6 permitted.
- PLACES OF WORSHIP**
Places of worship can remain open and ceremonial events is permitted, but you must not mix with those outside your household or support bubble.
- TRAVELLING**
You must stay at home. If you do leave home for a very limited set of exceptions, you should stay local in the village, town, or part of the city where you live where possible. Do not travel abroad unless an exemption applies.
- CLINICALLY EXTREMELY VULNERABLE**
Building introduced across England. You should not travel to work, school, college or university and should limit the time you spend outside the home. You should only go out for medical appointments, exercise or if it is essential.
- CARE HOME VISITS**
Visits can take place with arrangements such as substantial screens, visiting pods, or behind windows. Close contact indoor visits are not allowed. No visits will be permitted in the event of an outbreak but end of life visits are permitted in all circumstances.
