Scotland

Most of mainland Scotland remains at [Protection Level 2](#) of its [Strategic Framework](#). Glasgow City local council area remains at Level 3, but [will move to Level 2](#) from 5th June 2021 providing the key indicators used by the Scottish Government remain stable or fall.

Wales

All of Wales remains at its [Alert Level 2](#).

UK Vaccines Delivery Plan

Over [39.3 million people](#) across the UK had received the first dose of a COVID-19 vaccine and over 25.5 million had received their second dose, by the end of 30th May 2021. The government expects that three quarters of adults in the UK will have received a first dose during this coming week.

On 28th May 2021, the UK regulator, MHRA, approved the use of the [Janssen](#) single-dose COVID-19 vaccine for use in the UK.
