### [England](#)

England remains in Step 3 of the [roadmap to easing restrictions](#) which came into force on Monday 17<sup>th</sup> May 2021. The move to Step 4 is now expected to take place on Monday 19<sup>th</sup> July. Current restrictions and permitted activities in England are available [HERE](#).



[Weddings and wakes](#) may go ahead from 21<sup>st</sup> June 2021 with more than 30 people, providing social distancing is in place.

## **Scotland**

Scotland has five [COVID-19 Protection Levels](#) from 0 to 4. Each level has a different set of rules setting out what is permitted within a specific geographic area.

A rise in the Delta variant in England has led to the Scottish Government placing [travel restrictions](#) on Manchester and Salford.

## **Wales**

All of Wales remains at its [Alert Level 1](#). With effect from 21<sup>st</sup> June:

- Wedding, civil partnership receptions or wakes can take place in regulated premises such as hotels. The number of people is limited by venue size and a risk assessment.
- Overnight stays in residential outdoor education centres are allowed for primary school children.
